A consultation is when we ask people what they think about something.

This helps us to make decisions and plan our next steps.

The possible changes that we are planning



Hookstead and St Nicholas

We are thinking about stopping the day service at Hookstead.



If we do this, people would be offered

- a place at our St Nicholas day service or
- a different day service run by another organisation.



Linden Court and Beeching Park

We are thinking about stopping the day service at Linden Court.



If we do this, people would be offered

- a place at our Beeching Park day service or
- a different day service run by another organisation.



Steps to Work including Shine

We are thinking about closing the Steps to Work service including the Shine Car Wash in Lewes.



If we do this, people would be found employment support run by a different organisation instead of the Council.



Community Support Service

We are thinking about stopping the Community Support service that helps adults living independently at home.



If we do this, people would be found support from a different organisation instead of the Council.



We would still run the Supported Living part of the service, but there may be some changes to it.



If the changes are made to these services, the days or times you use a service may also need to change.

Why we are planning to make changes



We are thinking about making changes to the learning disability services we provide at the Council.



This is because we have less money to spend.



This means we have to make some difficult choices about what services we can afford to provide in the future.

We want to know what you think



We want you to tell us what you think about our plans before we make changes.

What you tell us will help us make decisions about our plans.



The survey is one way for you to tell us what you think.



There will also be meetings for people who use the services.

We will talk about our plans at these meetings.



If you use one of the services, you will receive a letter inviting you to the meetings.



You can also talk about the plans to the manager of the service you use.
