ROAD TRAFFIC REGULATION ACT 1984

**The East Sussex (A272 Main Road, Hadlow Down)
(30mph and 40mph Speed Limit) Order 202***

East Sussex County Council, in exercise of its powers under Section 84(1) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall drive a vehicle at a speed exceeding 30mph on that length of road specified in Schedule One to this Order.
2. No person shall drive a vehicle at a speed exceeding 40mph on that length of road specified in Schedule Two to this Order
3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3 (5) of those Regulations.
4. "East Sussex (A272 Hadlow Down) (30mph, 40mph and 50mph Speed Limit) Order 2009" is revoked in its entirety.
5. This Order may be cited as The East Sussex (A272 Main Road, Hadlow Down) (30mph and 40mph Speed Limit) Order 202*" and shall come into operation on DD MM YYYY.

**SCHEDULE ONE
30mph Speed Limit**

A272 Main Road, Hadlow Down	From a point 245 metres west of its junction with C11 School Lane to a point 25 metres east of its junction with U7582 Wheelers Lane.
C11 School Lane, Hadlow Down	From its junction with A272 north westwards for 495 metres.
St. Marks Field, Hadlow Down	For its entire length.
C508 Wilderness Lane, Hadlow Down	From its western junction with A272 south eastwards for 585 metres. From its eastern junction with A272 southwards for 505 metres.
U7582 Wheelers Lane, Hadlow Down	From its junction with A272 northwards for 180 metres.

SCHEDULE TWO
40mph Speed Limit

A272 Main Road, Hadlow Down	From a point 25 metres east of its junction with U7582 Wheelers Lane to a point 350 metres east of its junction with U7585 Tinkers Lane.
