ROAD TRAFFIC REGULATION ACT 1984

**The East Sussex (Alfriston Village)
(20mph, 30mph and 40mph Speed Limit) Order 2025**

East Sussex County Council, in exercise of its powers under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. The County Council of East Sussex (Built-Up Areas) Order 1936 Schedule 2, Item 12 'Alfriston' is hereby revoked.
2. The East Sussex (Wealden District) (30 mph Speed Limit) Order 1992 - No.2 II 'Parish of Alfriston' is hereby revoked.
3. The East Sussex (C39 Alfriston Road, Frog Firle, Firle) (40 mph Speed Limit) Order 2004 is hereby revoked.
4. No person shall drive a vehicle at a speed exceeding 20mph on those lengths of road specified in Schedule One to this Order.
5. No person shall drive a vehicle at a speed exceeding 30mph on those lengths of road specified in Schedule Two to this Order.
6. No person shall drive a vehicle at a speed exceeding 40mph on those lengths of road specified in Schedule Three to this Order.
7. No speed limit imposed by this Order applies to vehicles falling within Regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3 (5) of those Regulations.
8. This Order may be cited as "The East Sussex (Alfriston Village) (20mph, 30mph and 40mph Speed Limit) Order 2025" and shall come into operation on 21 July 2025.

20mph Speed Limit

C39 Whiteway	From a point 41 metres east of its junction with Cuckmere Road, eastwards to its junction with the C39 High Street.
C39 High Street	For its entire length.
C39 Waterloo Square	For its entire length.
U7726 Waterloo Square	For its entire length.
C39 North Street	From its junction with the C39 Waterloo Square to a point 7.5 metres southwest of the southwestern kerb line at the access road to The Willows car park.
U7728 Weavers Lane	For its entire length.

U7728 Star Lane	For its entire length.
U7728 Kings Ride	For its entire adopted length.
U7728 Deans Road	For its entire length.
U7728 Smugglers Close	For its entire adopted length.
U7728 The Broadway	For its entire length.
U7728 The Furlongs	For its entire length.
U7728 Cuckmere Court	For its entire length.
U7728 Saffron Gardens	For its entire length.
U7728 North Road	For its entire adopted length.
U7726 West Street	From its junction with the C39 Waterloo Square, to a point 20 metres northwest of the northern boundary of the property known as "Sloe Cottage".
U7727 Sloe Lane	For its entire adopted length.
U7125 River Lane	For its entire length.

SCHEDULE TWO
30mph Speed Limit


C39 North Street	From a point 41 metres south of its junction with Lullington Road, southwards to a point 7.5 metres southwest of the southwestern kerb line at the access road to The Willows car park.
C39 Whiteway	From a point 41 metres east of its junction with Cuckmere Road to a point 268 metres south of its junction with Cuckmere Road.

SCHEDULE THREE
40mph Speed Limit


C39 Whiteway	From a point 268 metres south of its junction with Cuckmere Road to the north-eastern boundary of the property known as "West Hill Cottages".
