**The East Sussex (B2096 Cade Street, Heathfield, Phase 2)
(Puffin Crossing and 40 mph Speed Limit) Order 2007**

East Sussex County Council, in exercise of its powers under section 84(1) and (2) of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall drive any vehicle at a speed exceeding 40 mph on those lengths of road specified in the Schedule to this Order.
2. This Order may be cited as "The East Sussex (B2096 Cade Street, Heathfield, Phase 2) (Puffin Crossing and 40 mph Speed Limit) Order 2007" and shall come into force on 7 July 2008.

**SCHEDULE
40 mph Speed Limit**

B2096 Cade Street/Park Wall Road -

from a point 186.53 metres north-east of its junction with the C589 Cade Street Lane in a north-westwards direction to a point 41 metres north-west of the prolongation of the northern wall of property number 1, Roundhouse Cottages, a distance of 603 metres.

School Hill

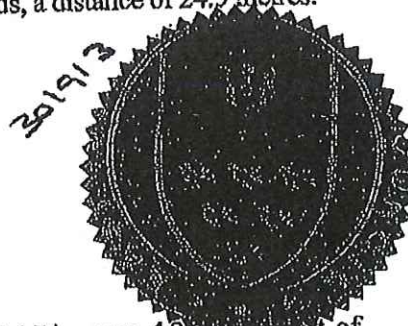
from its junction with the B2096 Cade Street south-eastwards to the existing 30mph limit signs on School Hill, a distance of 38.6 metres.

Halley Road

from its junction with the B2096 Cade Street northwards, a distance of 24.5 metres.

**The East Sussex (A265 Burwash Road & B2096 Battle Road, Heathfield)
(30mph & 40mph Speed Limit) Order 2024**

East Sussex County Council, in exercise of its powers under Section 84(1) and (2) of the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall drive a vehicle at a speed exceeding 30mph on those lengths of road specified in Schedule One to this Order.
2. No person shall drive a vehicle at a speed exceeding 40mph on those lengths of road specified in Schedule Two to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within Regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3 (5) of those Regulations.
4. The following parts of "The East Sussex (A265 Broad Oak, Heathfield) (30mph and 40mph Speed Limit) Order 2011", insofar as it relates to SCHEDULE TWO 40mph Speed Limit;

A265 Burwash Road - from a point 135m east of the centreline of B2203 Tower Street, eastwards to a point 11 metres west of the extension of the western kerblineline of Street End Lane and;

B2096 Parkwall Road - from the junction with the A265 Burwash Road, southeastwards for a distance of 230 metres.

are hereby revoked.

5. This Order may be cited as "The East Sussex (A265 Burwash Road & B2096 Battle Road, Heathfield) (30mph & 40mph Speed Limit) Order 2024" and shall come into operation on 29 April 2024.

SCHEDULE ONE
30 mph Speed Limit

Burwash Road	from a point 135 metres east of the junction with B2203 Tower Street, eastwards for a distance of 575 metres
Battle Road	from the junction with Burwash Road south-eastwards for a distance of 155 metres

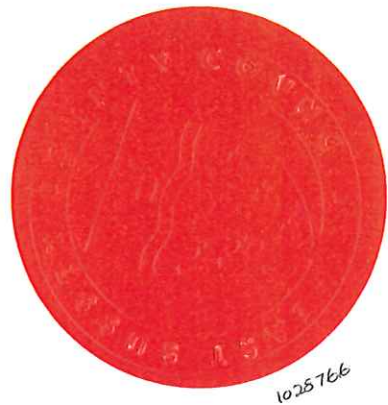
SCHEDULE TWO
40 mph Speed Limit

- Burwash Road** from a point 710 metres east of the junction with B2203 Tower Street, eastwards to a point 11 metres west of the junction with Street End Lane
- Battle Road** from a point 155 metres south of the junction with Burwash Road south-eastwards for a distance of 75 metres
