**The East Sussex (Rother District) (Parking Places, Waiting, No Stopping and Loading Restrictions) Traffic Regulation Order 2020 Amendment Order 202\* No\***

NOTICE is hereby given that East Sussex County Council propose to make an Order under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic act 1991, as amended, Part 6 of the Traffic Management Act 2024, and after the consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act which would introduce and revoke various restrictions in the following lengths of road in Bexhill:

Changes to **Prohibition of Waiting at Any Time** - Arthur Road, Chantry Avenue, Down Road, Downlands Avenue, Holliers Hill, Piltdown Close, Richmond Avenue, South Cliff, Terminus Avenue.

Changes to **No Waiting Monday to Saturday 8am - 6pm** - Down Road.

Introduction of **Loading/Unloading Goods Vehicles Only** - Colebrooke Road.
