THE BOROUGH OF BEXHILL (VARIOUS FOOTPATHS) (PROHIBITION OF CYCLING) ORDER, 1960

The Council of the Borough of Bexhill in exercise of the powers conferred upon them by subsection (2) of section 46 of the Road Traffic Act, 1930, subsection (4) of section 29 of the Road and Rail Traffic Act, 1933, and subsection (3) of section 33 of the Road Traffic Act, 1956, and of all other powers them enabling in that behalf hereby make the following Order:-

- 1. No person shall ride or cause or permit to be ridden any bicycle or tricycle on any of the lengths of footpath specified in the Schedule to this Order.
- The Interpretation Act, 1889, shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- This Order shall come into operation on the 1st day of September, 1960, and may be cited as "The Borough of Bexhill (Various Footpaths) (Prohibition of Cycling) Order, 1960."

No. Description of Footpath

- Footpath from a point on the south-western extremity of Clinch Green Avenue leading in a southerly direction to a point on the south side of Turkey Road 37 yards west of its junction with The Highlands.
- 2. Footpath from a point on the west side of Pankhurst Rise south of No. 1 leading in a south-westerly direction to Ashby Close.
- Footpath from a point on the south-west side of Ninfield Road 60 yards north-west of its junction with Southlands Road leading in a south-westerly direction to the eastern extremity of Blackmill Close.
- 4. Footpath from the western end of Davis Close leading in a westerly and southerly direction to a point in Turkey Road opposite Gunters Lane.
- 5. Footpath from the southern end of Highlands Close leading in a south-easterly direction to Footpath No. 4.
- 6. Footpath from a point in Turkey Road 93 yards east of its junction with Southlands Road leading in a northerly direction to Southlands Avenue.

- 7. Footpath from a point on the north side of Southlands
 Avenue 26 yards west of its eastern extremity leading
 in a northerly direction towards Ninfield Road for a
 distance of 65 yards.

 8. Footpath from a point on the south side of Camperdown
 Street adjoining the grounds of Sidley House leading in
 a southerly direction for a distance of 22 yards towards
 Turkey Road.

 9. Footpath from a point on the north side of the northern
 section of Grange Court Drive 300 yards west of its
 junction with Buxton Drive leading in a northerly
 direction through Sidley Wood to a point on the southwest side of St. Lawrence Road 40 yards east of its
 junction with Dalehurst Road.
 - 10. Footpath from a point on the north-east side of St. Lawrence Road 40 yards east of its junction with Dalehurst Road leading in a north-easterly direction to a point on the west side of Edmonton Road 65 yards north of its junction with Canada Way.
 - 11. Footpath from a point on the north side of Edmonton Road 85 yards west of its junction with Calgary Road leading in a north-easterly direction to a point opposite the north-western end of Calgary Road.
 - 12. Footpath from a point on the east side of Sidley Street
 75 yards north of its junction with Suffolk Road to a
 point in North Road 102 yards north of its junction with
 Suffolk Road.
 - 13. Footpath from the eastern end of Suffolk Road leading in a northerly direction along the western boundary of the cricket ground to Preston Road.
 - 14. Footpath from a point on the west side of Buxton Drive 98 yards south-west of its junction with Ninfield Road leading in a westerly direction to the north-eastern end of Bodle Crescent.
 - 14a. Footpath from a point at the south-west corner of Meadow Crescent leading in a south-westerly direction to Bank Road.
 - 15. Footpath from the north-westerly end of St. James Avenue leading in a south-westerly direction to Wrestwood Road.
 - 16. Footpath from the western end of Homelands Close to the western end of Uplands Close.
 - 17. Footpath from the northern end of Plemont Gardens leading

 in a north-westerly direction to a point in Glenleigh
 Avenue opposite Clevedon Road.
 - 17a. Footpath from a point on the south side of Glenleigh Avenue 100 yards west of its junction with Clevedon Road leading in a south-westerly direction to the eastern extremity of Broad View.
 - Footpath from a point at the south-west extremity of Grange
 Court Drive leading in a south-westerly direction to Old Farm Road.
 - 19. Footpath from a point on the west side of Buxton Drive 147 yards north of its junction with Grange Court Drive leading in a westerly direction through Sidley Wood to Footpath No. 9.

- 20. Footpath from a point on the east side of Buxton Drive 72 yards north of the junction of Buxton Drive and - Grange Court Drive leading to the south-easterly end of an accommodation road from Buxton Drive to Birch View. Footpath from a point at the northern end of Willingdon Avenue between Nos. 29 and 38 leading in a northerly and - north-westerly direction to Little Common Road. Footpath from the southern end of Bancroft Road leading 22. in a southerly and westerly direction to Bexhill Down and thence in a southerly direction along the western boundary
 - of the County Secondary School to Downs Road immediately west of the Down County Primary School.
 - 23. Footpath from a point on the west side of London Road __ immediately north of the Corporation Depot leading in a westerly direction under the railway to the southeastern end of Bancroft Road.

- 24. Footpath from a point on the north-east side of St. George's Road immediately opposite its junction with Springfield Road leading in a south-westerly direction along the boundary of the playground to London Road.
- Footpath from the southern end of Sewell Avenue leading in - a westerly direction to London Road.
- Footpath from a point on the west side of London Road 35 yards north of its junction with Salisbury Road leading -in a westerly direction under the railway and thence along the southern boundary of the County Secondary School to Bexhill Down.
- Footpath from a point at the junction of Barrack Road and Belle Hill leading in a westerly direction to a point in London Road 35 yards north of its junction with Salisbury Road.
- Footpath from the eastern end of Hillside Road leading in a northerly direction to the southern end of St. David's - Avenue thence in a north-westerly direction to the southern end of St. Andrews's Road.
- Footpath from a point on the north-west side of Barrack Road immediately south-west of Chantry Primary School leading in a north-westerly direction to the southern end of St. David's Avenue.
- 30. _Footpath from the northern end of Millfield Rise leading in a northerly direction to Belle Hill.
- 31. Footpath from a point in Holliers Hill opposite Church Vale Road leading in a southerly direction to Barrack Road at a point immediately west of the Cemetery.
- 32. Footpath from a point on the north-east side of Wrestwood Road 127 yards south-east of its junction with St. James Road leading in a north-easterly direction to the eastern end of St. James Avenue.
- 33. Footpath from a point on the south side of Wrestwood Road 55 yards south-east of its junction with St. John's Road leading in a southerly direction to a point in Chantry Avenue 80 yards south-west of its junction with Wychurst Gardens.

- 34. Footpath commencing from a point in Wrestwood Road immediately west of the Corporation Water Depot and Leading along the western boundary of the grounds of St.Mary's School, Wrestwood, to the junction with Footpath No. 35.

 35. Footpath commencing at St, Peter's Church, passing in part along the southern boundary of the grounds of St.Mary's School, Wrestwood, and Leading into Wrestwood Road at a point 167 yards north-west of Pebsham Lane.

 36. Footpath from a point in Pebsham Lane 70 yards south of its junction with Seabourne Road Leading in a south-easterly direction crossing in turn Rowan Gardens and Laburnum Gardens to a point in Maytree Gardens immediately west of its junction with Third Avenue.

 37. Footpath from a point on the west side of Haslam Crescent
 - 37. Footpath from a point on the west side of Haslam Crescent 55 yards north of its junction with Third Avenue leading in a south-westerly direction to the north-eastern extremity of Royston Gardens.
 - 38. Footpath from a point at the western end of York Road leading in a north-westerly direction to Glyne Drive.
 - 39. Footpath from a point on the east side of Cooden Sea Road 123 yards south of its junction with Collington Lane and leading in an easterly direction to Collington Lane.
 - 40. Footpath from a point on the west side of the northern end of Willingdon Avenue to a point in Glenthorn Road 63 yards north of its junction with Saxby Road.
 - 41. Pootpath from a point on the south side of Little Common Road 50 yards east of the Sports Centre leading in a south-westerly direction to Arthur Road immediately south of the Sports Centre.
 - 42. Footpath from the western end of Victoria Road passing beneath the railway to the junction of Colebrooke Road and Cranston Avenue.
 - 43. Footpath from a point in Terminus Road approximately 80 / yards east of the junction of Terminus Avenue and Collington Avenue and leading in a southerly direction beneath the railway to Wickham Avenue.
 - 144. Footpath over the railway from Station Road to Endwell Road.
 - Footpath from a point on the east side of Upper Sea Road 51 yards north of its junction with Buckhurst Road leading in an easterly direction along the southern boundary of the Metropolitan Convalescent Home to the northern end of Rotherfield Avenue and continuing in an easterly direction to the western extremity of Old Manor Close.
 - Footpath from a point on the south side of De La Warr Road 20 yards west of the southern end of Penland Road leading in a southerly direction to a point 63 yards north of the eastern end of Ashdown Road.
 - 47. Footpath from a point immediately south of the railway bridge at the eastern end of Ashdown Road leading in a westerly and southerly direction along the eastern boundary of the Alf Evans Convalescent Home to De La Warr Parade.
