East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 49, 51, 52, 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended, the Road Traffic Act 1991 (as amended), Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Commencement and citation

This Order may be cited as "The East Sussex (Rother District) (Parking Places, Waiting, No Stopping and Loading Restrictions) Traffic Regulation Order 2020 Amendment No.1 Order 2021 (Camber Clearway).

2. When this Order comes into effect:

(a) The East Sussex (Rother District) (Parking Places, Waiting, No Stopping and Loading Restrictions) Traffic Regulation Order 2020, as amended, shall have effect except as hereinafter contained:

(i) Part II — Waiting and Loading restrictions and designation of Parking Places, that the following article shall be inserted:

3	(7)	No person shall cause or permit any vehicle to stop or remain at rest at any time on any of the main carriageway of the lengths of road as specified in the Order Plans as having a 'Rural Clearway' restriction.

(ii) Other exemptions, that the following article shall be deleted:

8.2	Nothing in Part II of this Order shall render it unlawful to cause or permit a vehicle to wait in any street or length of street specified in the Order Plans as No Waiting At Any Time or No Waiting during certain times, as a restricted street, Pay and Display, Permit Holder Only, or Permit Holder or Pay and Display parking places:

8.2	Nothing in Part II of this Order shall render it unlawful to cause or permit a vehicle to wait in any street or length of street specified in the Order Plans as No Waiting At Any Time or No Waiting during certain times, Rural Clearway, No Stopping on Entrance Markings, as a restricted street, Pay and Display, Permit Holder Only, or Permit Holder or Pay and Display parking places:

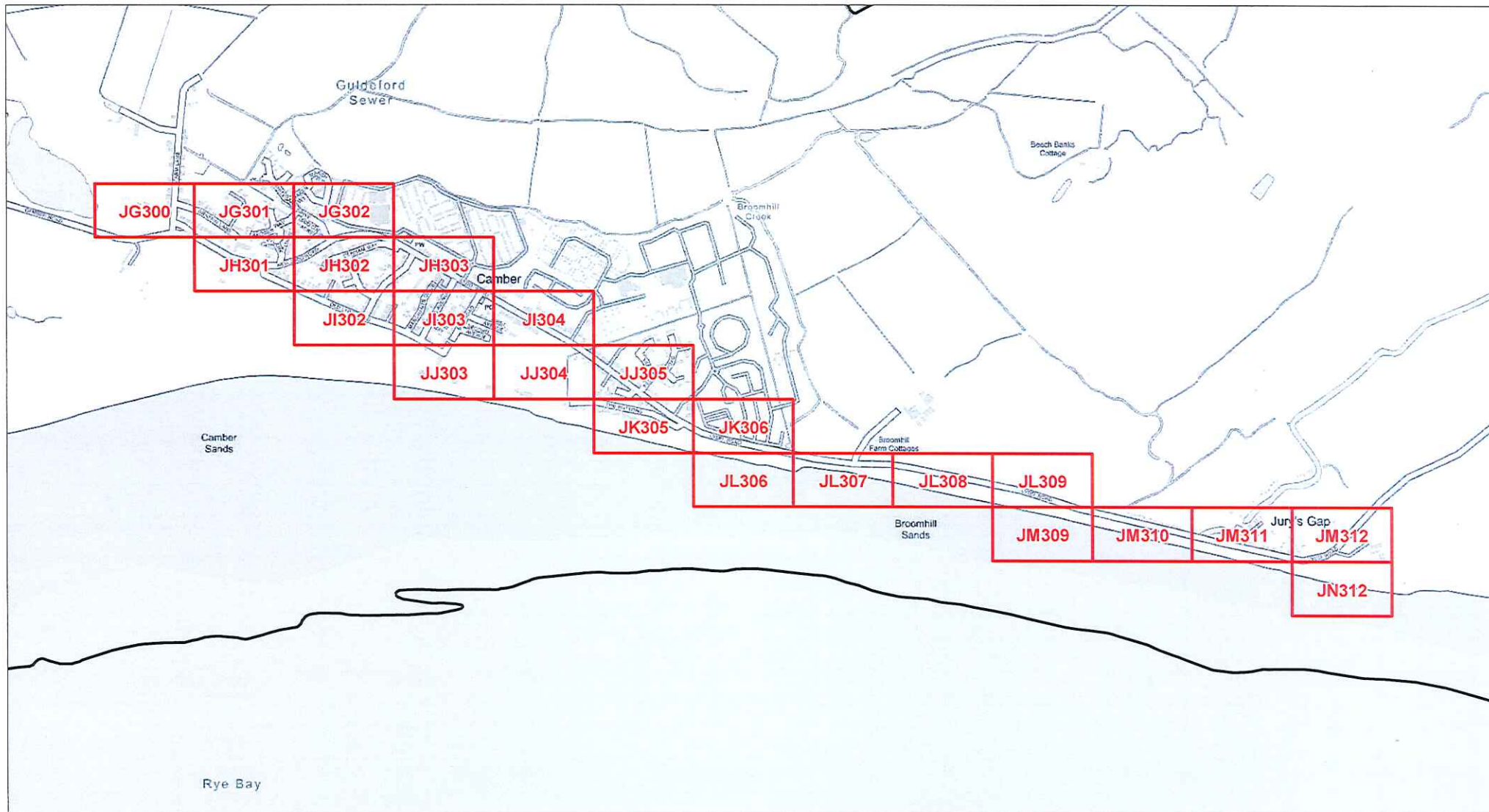
