East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping, Loading, Unloading and Parking Places)(Wealden District Consolidation) Order 2025 Amendment * 202* (Camberlot Road, Upper Dicker)

East Sussex County Council, in exercise of its powers under Sections 1(1) and 2(1) to (3) and 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. Commencement and citation

This Order may be cited as "East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping, Loading, Unloading and Parking Places)(Wealden District Consolidation) Order 2025 Amendment * 202* (Camberlot Road, Upper Dicker)" and shall come into operation on DD/MM/YYYY.

2. When this Order comes into effect:

- (i) East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping, Loading, Unloading and Parking Places)(Wealden District Consolidation) Order 2025 Amendment * 202* (Camberlot Road, Upper Dicker) as amended shall have effect except as hereinafter contained:

Without prejudice to the validity of anything done prior or to any liability incurred in respect of any act or omission before the coming into operation of this Order, East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping, Loading, Unloading and Parking Places)(Wealden District Consolidation) Order 2025 Amendment * 202* (Camberlot Road, Upper Dicker) have effect subject to the variations, insertions, substitutions, removals and additions specified in the map schedules and map schedule legends of this Order:-

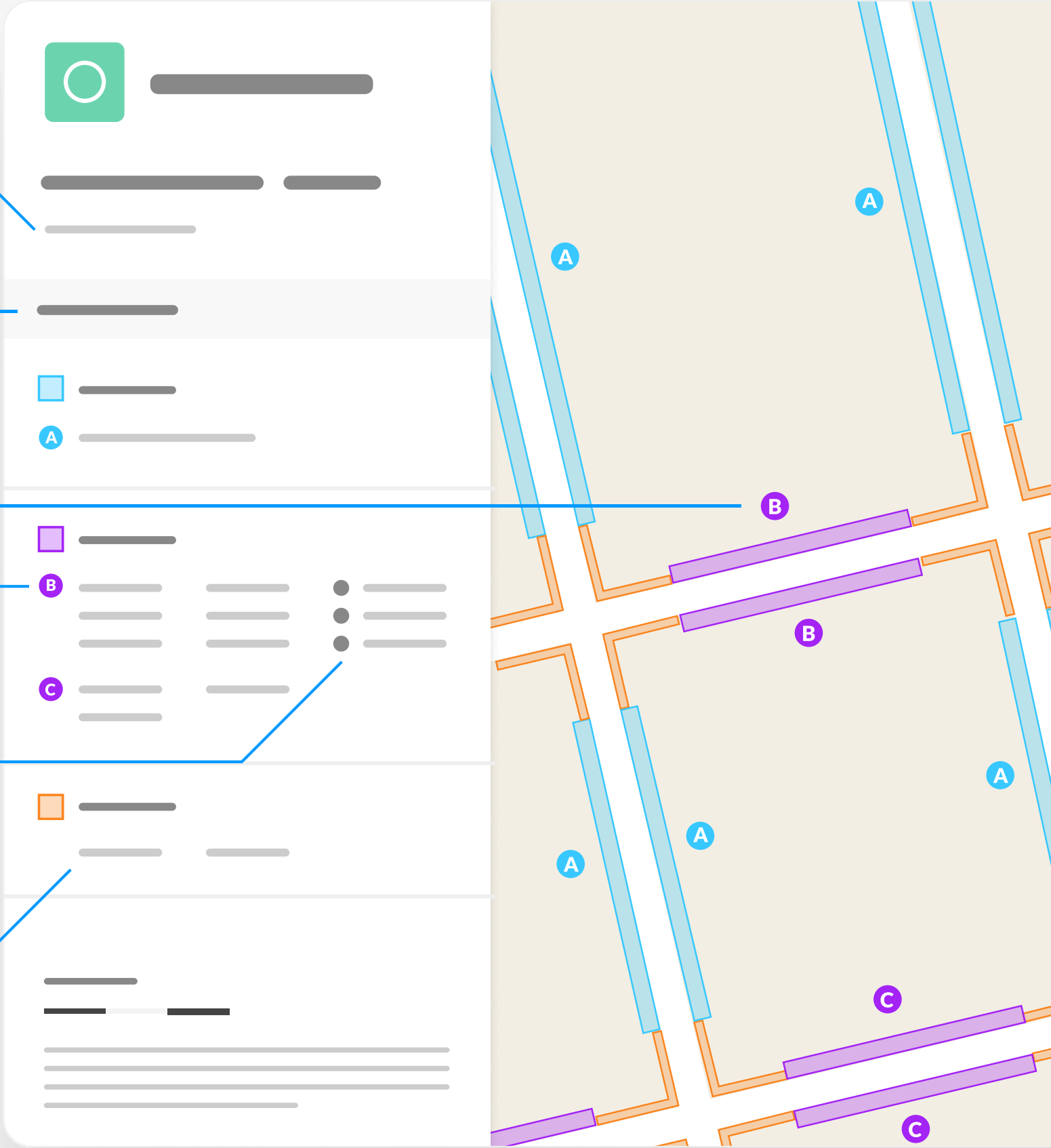
