**THE EASTBOURNE (PRESCRIBED ROUTES) (CONSOLIDATION No. 2) ORDER 2008
AMENDMENT ORDER 2026 No.1 (ETCIS PHASE 2B)**

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. When this Order comes into effect

(a) The Eastbourne (Prescribed Routes) (Consolidation No 2) Order 2008 as amended, shall have effect except as hereinafter contained.

(i) Schedule One, One Way Traffic, that this Schedule be amended as follows:

1 Delete items 4, 38 and 45 as follows;

4	Burlington Road	Northeastwards from its junction with Elms Road to its junction with Elms Avenue.
38	Seaside Road	Northeastwards from its junction with Terminus Road to its junction with Cavendish Place
45	Terminus Road	Northwestwards from its junction with Grand Parade to its junction with Seaside Road

2 Insert items 4, 38 and 45 as follows:

4	Burlington Road	Northeastwards from its junction with Terminus Road to its junction with Elms Road
11.1	Elms Road	Northeastwards from 20m southeast of the junction with Elms Avenue to the junction with Elms Avenue
38	Seaside Road	Northeastwards from its junction with Terminus Road to its junction with Cavendish Place
45	Terminus Road	Southeastwards from its junction with Seaside Road to its junction with Burlington Road
51.1	Trinty Trees	Northeastwards from its junction with Trinity Place to its junction Terminus Road

(ii) Schedule Four, Banned Movements, that this Schedule be amended as follows:

1 Part D: Left turn only, insert items 0.1 and 2.2 as follows;

0.1	Elms Road	Left turn only into Burlington Road.
2.2	Terminus Road	Left turn only into Burlington Road

(iii) Schedule Five, Prohibition of Vehicles, that this Schedule be amended as follows:

1 Part A: Prohibition of driving, insert item 15 as follows;

15	Terminus Road	From its junction with Grand Parade to its junction with Burlington Road

2 Part B: Prohibition of entry, delete item 21 as follows;

21	Seaside Road	No entry southeastwards into Terminus Road

3 Part B: Prohibition of entry, insert item 23 as follows;

23	Terminus Road	Southeastwards from its junction with Burlington Road

2. This Order may be cited as "The Eastbourne (Prescribed Routes) (Consolidation No 2) Order 2008 Amendment Order 2026 No.1 (ETCIS Phase 2B)" and shall come into effect on 13 February 2026.
