ROAD TRAFFIC REGULATION ACT 1984

**The East Sussex (Borough of Hastings)(Traffic Regulation)(Consolidation) Order 2013
(Various Roads) Amendment Order 2022 No. 1**

Notice is hereby given that East Sussex County Council have made the above Order under the relevant sections of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, coming into operation on 18 April 2022, which will introduce new, or revise the existing parking, waiting, stopping and loading restrictions along the following lengths of road:-

Changes to **Prohibition of Waiting At Any Time** in the following roads: Brightling Avenue, Churchill Avenue, Collier Road, Hare Way, Harley Shute Road, Holmesdale Gardens, Hughenden Road, Lower Park Road, Middle Road, Montgomery Road, Sea Road, South Street

Changes to **Residents Parking Places for Residents Permit Holders, Residents Visitors, & Business User Permit Holders Only 9.00am to 8.00pm On All Days** in the following roads: Dorset Place, Stone Street, Croft Road, East Parade

Changes to **Residents Parking Places for Residents Permit Holders, Residents Visitors, & Business User Permit Holders Only, 11.00am to 1.00pm Monday to Friday** in the following road: Alexandra Road

Changes to **Waiting Area Parking Places Limited to Two Hours in any period of Four Hours, Monday to Saturday 9.00am to 6.00pm (Residents, Residents Visitors, & Business User Permit Holders Excepted)** in the following road: Holmesdale Gardens

Changes to **Waiting Area Parking Places Limited to Two Hours in any period of Four Hours, Monday to Saturday 9.00am to 4.00pm (Residents, Residents Visitors, & Business User Permit Holders Excepted)** in the following road: Lower Park Road

Changes to **Waiting Area Parking Places Limited to Two Hours in any Period of Four Hours, 9.00am to 8.00pm On All Days (Residents Permit Holders, Residents Visitors, and Business User Permit Holders Excepted)** in the following road: Old London Road

Changes from **On Street Pay and Display Parking Places At Hastings Waiting Area Limited To Four Hours In Any Period of Eight Hours 9.00am to 6.00pm On All Days to Permit Holder Parking (no maximum stay) or On Street Pay And Display Parking Waiting Area Limited To Four Hours In Any Period Of Eight Hours, 9.00am to 8.00pm On All Days** in the following road: St Margaret's Road

Changes from **Parking Places At Hastings For Cars Light Vans And Motorcycles Only At Any Time On All Days; On Street Pay And Display Parking Waiting Area Limited To Four Hours In Any Period Of Eight Hours 9.00am to 6.00pm On All Days to Permit Holder Parking (no maximum stay) or On Street Pay And Display Parking Waiting Area Limited To Four Hours In Any Period Of Eight Hours, 9.00am to 8.00pm On All Days** in the following road: White Rock Road

Changes to **Permit Holder Parking (no maximum stay) or On Street Pay And Display Parking Waiting Area Limited To Two Hours In Any Period Of Four Hours, 9.00am to 8.00pm On All Days** in the following road: Wellington Square

Changes from **No Stopping Except for Licensed Taxis, 8.00am – 6.00pm On All Days to Waiting Area Limited to One Hour in any period of Three Hours Monday to Saturday 8.00am to 6.00pm Inclusive** in the following road: Sedlescombe Road North

The introduction of and changes to **Disabled Persons Parking Places** in the following roads: Alexandra Road, Ashburnham Road, Blackman Avenue, Burry Road, Cranbrook Road, Croft Road, Dorset Place, Duke Road, Fellows Road, Gordon Road, Hardwicke Road, Hughenden Road, Kenilworth Road, Mount Pleasant Road, Newgate Road, Pennine Rise,

Rye Road, Rymill Road, St Paul's Road, Stone Street, The Slides

The introduction of **Disabled Persons' Parking Places At All Times with Waiting Limited to Four Hours in any period of Eight Hours between 8am and 6pm On All Days** in the following roads: Denmark Place, Middle Street, Pelham Street, Robertson Terrace, Russell Street, Waldegrave Street, Wellington Square

The removal of the following road in **Doctors' Parking Places**: Wellington Square

The removal of the following road in **Bus/Public Service Vehicle Parking Places Between the Hours of 8.00 am and 6.00 pm On All Days**: Dane Road

The removal of the following road in **Parking Places At Hastings for Buses and Public Service Vehicles Only, Waiting Area Limited To Thirty Minutes In Any Period Of Two Hours and Thirty Minutes, 8.00am to 6.00pm On All Days**: East Parade

The removal of **Loading Bays All Hours On All Days** and the introduction of **Loading Bay 8.00am to 6.00pm On All Days** in the following road: Collier Road

The introduction of **Prohibition of Stopping On The Footway At Any Time** in the following roads: Brightling Avenue, Castle Hill Road, Middle Road

Changes to **Prohibition of Stopping On The Footway or Verge At Any Time** in the following road: Harley Shute Road

The introduction of **No Stopping Between 8.00am and 9.30am And Between 2.30pm and 4.00pm Monday to Friday Except August** in the following road: Hare Way

The introduction of 'G' permit eligibility to **Waiting Area Parking Places Limited to Two Hours in any period of Four Hours, Monday to Saturday 9.00am to 6.00pm (Residents, Residents Visitors, & Business User Permit Holders Excepted)** in the following road: Becket Mews/ Old School Path

The introduction of 'H' permit eligibility to **Waiting Area Parking Places Limited to Two Hours in any period of Four Hours, Monday to Saturday 9.00am to 6.00pm (Residents, Residents Visitors, & Business User Permit Holders Excepted)** in the following road: Stanley Gardens

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act of 1984, or on the grounds that any requirement of the Road Traffic Regulation Act or of any instrument made under it has not been complied with in relation to the Order, may within six weeks of the date the Order is made, apply to the High Court for this purpose.
