**The East Sussex (Borough of Hastings) (Traffic Regulation) (Consolidation)
Order 2013 (Various Roads) Amendment Order 201* No. ***

Notice is hereby given that East Sussex County Council propose to make the above Order under the relevant sections of the Road Traffic Regulation Act 1984, as amended, which will introduce new, or revise the existing parking, waiting, and loading restrictions along the following lengths of road:-

Changes to **Prohibition of Waiting At Any Time** in the following roads:
Chanctonbury Drive, Cornwallis Terrace, Grange Road, Hillside Road, Kenilworth Road, Little Ridge Avenue, Middle Road, Nelson Road, Old Top Road, Parkstone Road, Pevensey Road, Robsack Avenue, Rothsay Road, Silvan Road, St Paul's Road, Upper Maze Hill

Changes to **Prohibition of Waiting between 8.00am and 6.00pm Monday to Friday** in the following road: Hillside Road

Changes to **Prohibition of Loading At Any Time** in the following roads:
All Saints Street, Claremont, Fairlight Road, Old London Road, Queens Road, Saxon Road, Victoria Avenue

Changes to **Prohibition of Loading between 8.30am and 9.30am and between 4.45pm and 6.00pm Monday to Saturday** in the following roads: Old London Road, Victoria Avenue

Changes to **Residents Parking Places for Residents Permit Holders, Residents Visitors, & Business User Permit Holders Only, 9.00am to 8.00pm On All Days** in the following roads: Linton Road, Marine Parade Service Road

Changes to **(Residents, Residents Visitors, & Business User Permit Holders Excepted) Waiting Area Parking Places Limited to Two Hours in any period of Four Hours, Monday to Saturday 9.00am to 6.00pm** in the following roads:
Baldslow Road, Braybrooke Road, Nelson Road, Milward Crescent, Milward Road, Stanley Road

Changes to **Parking Places for use by Business User Permit Holders Only, 9.00am to 8.00pm On All Days** in the following road: Linton Road

Change from **On Street Pay And Display Parking Places At Hastings, Waiting Area Limited to Two Hours In Any Period of Four Hours, 9.00am to 6.00 pm On All Days to Permit Holder Parking (no maximum stay) or On Street Pay And Display Parking, Waiting Area Limited To Two Hours In Any Period Of Four Hours, 9.00am to 8.00pm On All Days** in the following road: The Bourne

Changes to **Waiting Area Limited to Two Hours in any period of Four Hours, Monday to Saturday, 8.00am to 6.00pm Inclusive** in the following roads: Beaufort Road, Bexhill Road, Little Ridge Avenue

Changes to **Disabled Persons Parking Places** in the following roads: Ashburnham Road, Baldslow Road, Beaconsfield Road, Braybrooke Road, Castle Hill Road, Edinburgh Road, Emmanuel Road, Hardwicke Road, Hughenden Road, Malvern Way, Manor Road, Marina, Pevensey Road, Saxon Street, Stainsby Street, St George's Road, Stanley Road, The Ridge, Wilmington Road

Changes to **Police Parking Places** in the following road: North Road

Changes to **Prohibition of Stopping On The Footway or Verge At Any Time** in the following roads: Burton Way, East Beach Street, Eversfield Place, Marine Parade, The Bourne, Winchelsea Lane

The introduction of **No Stopping Between 8.00am and 9.30am and Between 2.30pm and 4.00pm Monday to Friday On School Entrance Markings During School Term Time** in the following roads: Brightling Avenue, Middle Road

Changes to **Cycles Lanes** in the following road: East Beach Street
