EAST SUSSEX COUNTY COUNCIL (PROHIBITION AND RESTRICTION OF WAITING, NO STOPPING, LOADING, UNLOADING AND PARKING PLACES) (LEWES DISTRICT CONSOLIDATION) ORDER 2025 AMENDMENT 1 2025

Notice is hereby given that East Sussex County Council have made the above Order on 26 September 2025, under the relevant sections of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers coming into operation on 29 September 2025 which introduces, amends and revokes various restrictions along the following lengths of roads:

Replacement of a section of **Permit Holder Parking Places, Monday to Saturday, 8am-8pm** with a **Disabled Persons Parking Place 8am-8pm maximum stay 3 hours no return within 1 hour** in the following road: **Lewes - Albion Street.**

Removal of a section **Time limited Parking Places, Monday to Saturday, 8am-6pm** and its replacement of **Prohibition of Waiting At Any Time** in the following road: **Newhaven - Bridge Street.**

Replacement of a section of **Permit Holder Parking Places, Monday to Saturday, 8am-8pm** and with a **Disabled Persons Parking Place At Any Time** in the following road:
Lewes - East Street.

Replacement of **Permit Holder or Pay and Display Parking Places, Monday to Saturday, 9am-5pm** with **Disabled Persons Parking places 9am-5pm maximum stay 3 hours no return within 1 hour** in the following road: **Lewes - Court Road.**

Removal of a small section of **Prohibition of Waiting At Any Time** and removal of **Permit Holder or Pay and Display Place Monday to Saturday 9am-5pm**, and its replacement with **Disabled Parking Place 9am-5pm maximum stay 3 hours no return within 1 hour** in the following road: **Lewes - Brook Street.**

Introduction of **School Keep Clear Monday to Friday 8am-9:30am and 2.30pm-4pm except August** in the following roads: **Newick - Church Road. Ditchling - Lewes Road.**

Changes to **No Waiting At Any time** in the following roads: **Lewes - Lee Road, Old Malling Way, Brook Street, Peacehaven - Sussex Way, Telscombe Cliffs Way, St Peters Avenue, Hodder Avenue, Arundel Road West. Newhaven - Elphick Road, Lewes Road, Evelyn Avenue, Railway Road.**

Replacement of **Disabled Persons Parking Places** to **Disabled Parking Place 9am-6pm maximum stay 3 hours no return within 1 hour** in the following roads:
Lewes - High Street, Station Street, Morris Road.

Introduction of **Disabled Persons Parking Places At Any Time** in the following roads:

Newhaven - Evelyn Avenue, Lawes Avenue. **Lewes** - Evelyn Road

Changes to **No Waiting Monday to Saturday 7am-7pm** in the following road:

Lewes - Newton Road, Crisp Road.

Introduction of **No Waiting Monday to Saturday 7am-7pm** in the following roads:

Lewes - Waldshut Road, Blois Road.

Replacement of **No Waiting Monday to Friday 7am-7pm** to **No Waiting Monday to Saturday 7am-7pm** in the following road: **Lewes** - Newton Road.

Replacement of **Permit Holder or Pay and Display Parking Places, Monday to Saturday, 8am-6pm** with **Disabled Persons Parking place 8am-6pm maximum stay 3 hours no return within 1hour** in the following road: **Lewes** - Grange Road.

Replacement of **Permit Holder Only Parking Places, Monday to Saturday, 9am-5pm** with **Disabled Persons Parking At Any Time** the following road: **Lewes** - Sun Street.

Introduction of **School Keep Clear Monday to Friday 7.30am-9:30am and 4pm-6pm except August** in the following road: **Newhaven** - Railway Road.

Replacement of **Permit Holder Only Parking Places, Monday to Friday, 8am-6pm** with **No Waiting At Any time** in the following road: **Lewes** - Valley Road.

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act of 1984, or on the grounds that any requirement of the Road Traffic Regulation Act or of any instrument made under it has not been complied with in relation to the Order, may within six weeks of the date the Order is made, apply to the High Court for this purpose.
