Statement of Reasons

 In order to increase parking provision for permit holders in zone C it is proposed to introduce new or make changes to existing Permit Holders Only bays and Permit Holder or Pay and Display bays in the following road: South Street.

Further changes have been proposed which will ratify some of the provisions in the Traffic Regulation Order and which will have no physical change on site.
