Notice is hereby given that East Sussex County Council propose to make the above Order under the relevant sections of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers, which will introduce new or revise the existing parking, waiting and loading restrictions along the following lengths of roads:

The introduction of **Prohibition of Waiting At Any Time** in the following roads: **PEACEHAVEN** - Glynn Road. **NEWICK** - Allington Road. **RINGMER** - Bishops Lane.

Changes to **Prohibition of Waiting, 8am to 6pm Monday to Saturday except Taxis** in the following roads:

SEAFORD - Broad Street, Pelham Road.

Changes to **Prohibition of Waiting At Any Time** in the following road:

NEWHAVEN - Marshall Lane

Changes to the Time Limited Waiting maximum stay 12 hours in the following roads:

SEAFORD - Esplanade, Marine Parade

The introduction of **Parking Area Limited waiting 12 hours no return within 2 hours** in the following road:

Seaford - Esplanade.

Changes to **Disabled Persons Parking Places** in the following road:

North Chailey - Downs View

The introduction of Time Limited Waiting, 8am to 6pm Monday to Saturday, maximum stay 4 hours no return within 2 hours in the following road:

Newhaven - Fort Road.

The removal of **Time Limited Waiting**, **8am to 6pm Monday to Saturday**, **maximum stay 1 hour** in the following road:

NEWHAVEN - Fort Road.

The introduction of **Prohibition of Waiting except Taxis** in the following road:

SEAFORD - Pelham Road.

The introduction of **Loading and Unloading only 8am to 6pm Monday to Saturday** in the following road: **Seaford** - Broad Street.

Changes to School Keep Clear Marking, in the following roads:

KINGSTON - Wellgreen Lane. PEACEHAVEN - Cripps Avenue.

The introduction of Car Club Bay At Any Time in the following road:

PEACEHAVEN - Meridian Way.

Statement of Reasons

The County Council has a duty under section 122 of the Road Traffic Regulation Act 1984 when making TROs to consider the expeditious, convenient and safe movement of traffic and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. The East Sussex County Council as traffic authority propose to make the above-named order:

- a) For safety reasons in order to prohibit waiting at all times at certain junctions to preserve sight lines facilitate turning movements.
- b) To improve the air quality by improving traffic flow and reducing congestion.
- c) To ensure and facilitate free flow of traffic and access/egress.
- d) To improve levels of available parking and manage parking demands.
- e) For preserving or improving the amenities of the area through which the road run s:

as indicated in the documents and map deposited.

These proposals are being promoted under the provisions of the Road Traffic Regulation Act 1984 which allows the Council to take measures under Section 1.

In accordance with the above ESCC propose the following amendments to the above order.

- In order to improve access, it is proposed to introduce Bus Stop Clearway in the following road:
 Kiln Road Ringmer
- In order to maintain access, to prevent obstruction and to maintain visibility at junctions, it is necessary to propose new or to make changes to existing No Loading and Unloading At Any Time restrictions in the following roads:
 Glynn Road Peacehaven, Bishops Lane Ringmer, Allington Road Newick Marshall Lane Newhaven.

• In order to ensure effective enforcement and maintain safety near schools it is proposed to make changes and formalise the existing advisory school keep clear markings in the following roads:

Wellgreen Lane Kingston, Cripps Avenue Peacehaven.

 Following request made by Lewes District Council and ESCC department it is proposed to remove the existing Time Limited bays and propose new Time Limited bays in the following road:

Fort Road Newhaven

 Following reports made by ESCC departments it is proposed to remove the existing Taxi bays and replace with Loading/Unloading only bays in the following road:

Broad Street Seaford.

• Following requests made by residents and chair of Lewes District Council Licensing Committee it is proposed to change the existing Taxi bays in the following road:

Pelham Street Seaford

• Following request made by ESCC departments it is proposed that Car Club bay at any time be introduced in the following road:

Meridian Way Peacehaven

• In order to ensure effective enforcement, it is proposed to make changes to and introduce new Time limited bays in the following roads:

Esplanade, Marine Parade Seaford

• In order to prevent obstruction and ensure effective enforcement, it is proposed to make changes to Disabled Persons Parking Places in the following road:

Downs View North Chailey

Some of the changes have been proposed to ratify some of the provisions in the Traffic Regulation Order and will have no physical change on site.

East Sussex County Council, in exercise of their powers under Sections 1(1), 2(1) to (4), 3(2), 4(2), 32, 35(1) and (3), 45, 46, 49, 51, 52 and 53 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), as amended, the Road Traffic Act 1991, as amended, Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Commencement and citation

This Order may be cited as "The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No 1 (Amendment No *) 202* and shall come into effect on xxxxxx

2. When this Order comes into effect:

(a) The East Sussex (Lewes District) (Traffic Regulation) Order 2004 Amendment Order 2005 No.1, as amended, shall have effect except as hereinafter contained.

(i) Schedule 1, Part A, Prohibition of Waiting At Any Time, that this Schedule be amended as follows:

1. In the list of restrictions for Ringmer, the following item shall be added as follows:

Bishops Lane	East Side	From its junction with Lewes Road, northwards for a distance of 9.5 metres.
Bishops Lane	West Side	From its junction with Lewes Road, northwards for a distance of 11 metres.

2. In the list of restrictions for Newick, the following items shall be added as follows:
