
East Sussex County Council, in exercise of their powers under Section 84(1) and (2) of the Road Traffic Regulation Act 1984 ("the Act") as amended, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

- 1. No person shall drive any vehicle at a speed exceeding 40 mph on that length of the B2102 High Street, Blackboys which extends from its junction with the B2192 to a point 172 metres west of the western kerbline of School Lane.
- 2. This Order may be cited as "The East Sussex (B2102 High Street, Blackboys) (40 mph Speed Limit) Order 1990" and shall come into operation on 22 October 1990.

- 3. No person shall drive any vehicle at a speed exceeding 40 mph on those lengths of road specified in the Second Schedule to this Order.
- 4. No person shall drive any vehicle at a speed exceeding 50 mph on those lengths of road specified in the Third Schedule to this Order.
- 5. This Order may be cited as "The East Sussex (Buxted, Framfield & Blackboys) (30 mph, 40 mph & 50 mph Speed Limit) Order 2005" and shall come into force on 19 August 2005.
