**East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping,
Loading, Unloading and Parking Places)(Hastings Borough Consolidation) Order
2025 Amendment 1 2025 (Whitworth Road)**

East Sussex County Council, in exercise of its powers under Sections 1(1) and 2(1) to (3) and 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. Commencement and citation

This Order may be cited as “East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping, Loading, Unloading and Parking Places)(Hastings Borough Consolidation) Order 2025 Amendment 1 2025 (Whitworth Road)” and shall come into operation on 3 November 2025.

2. When this Order comes into effect:

- (i) East Sussex County Council (Prohibition and Restriction of Waiting, No Stopping, Loading, Unloading and Parking Places)(Hastings Borough Consolidation) Order 2025 as amended shall have effect except as hereinafter contained:

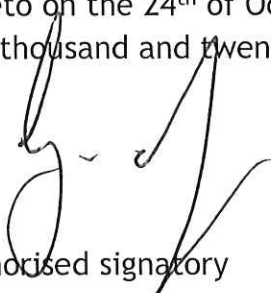

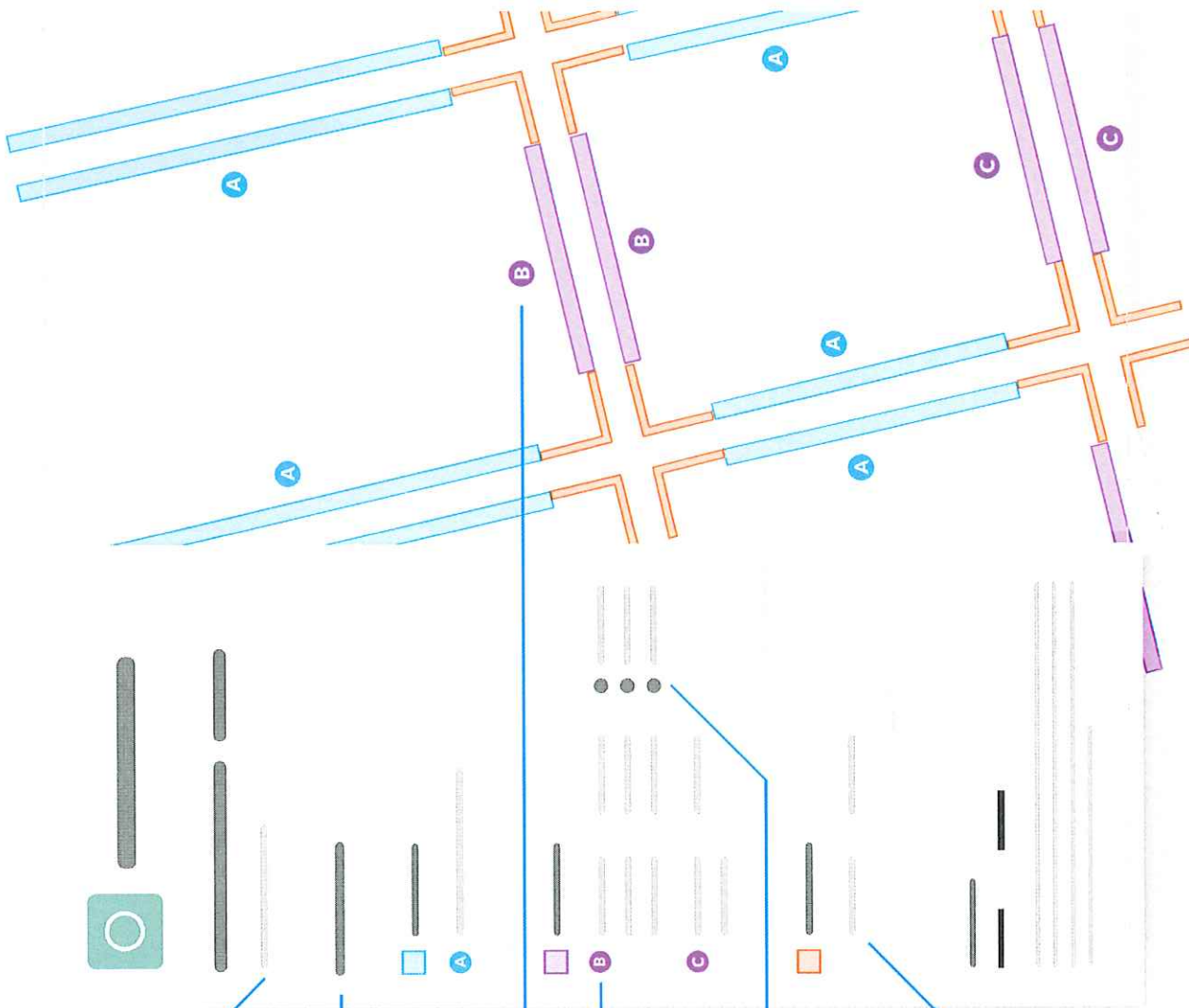
