LOADING, UNLOADING AND PARKING PLACES) (ROTHER DISTRICT CONSOLIDATION) ORDER
2025 AMENDMENT NO.1 2026**

Notice is hereby given that East Sussex County Council have made the above Order, on 24 July 2026, under the relevant sections of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers which will introduce new or revise the existing parking, waiting and loading restrictions along the following lengths of road:-

Changes to Prohibition of Waiting At Any Time - Cooden Drive Bexhill, Egerton Road Bexhill, Harbour Road Rye, Magdalen Road Bexhill, North Trade Road Battle, Station Road Hurst Green, Station Road Robertsbridge

Changes to Time Limited Mon to Sat 9am-5pm maximum stay 1 hour no return within 1 hour
- Station Road Robertsbridge

Changes to Time Limited 8am-6pm maximum stay 2 hours no return within 2 hours -
Parkhurst Road Bexhill

Changes to Permit Holder or Time Limited 8am-6pm maximum stay 2 hours no return within 2 hours - Magdalen Road Bexhill

Changes to Permit Holder or Time Limited Mon to Sat 8am-6pm maximum stay 2 hours no return within 2 hours - Buckhurst Road Bexhill, Manor Road Bexhill, Reginald Road Bexhill

Changes to Taxis Only At Any Time - Buckhurst Place Bexhill, Devonshire Road Bexhill

Introduction of Prohibition of Waiting At Any Time - Battle Gates Battle, Cooden Drive Bexhill, Lower Lake Battle, North Trade Road Battle, Old Marsh Road Bexhill, Richmond Avenue Bexhill, Richmond Close Bexhill, Richmond Grove Bexhill, Richmond Road Bexhill, Ridgewood Gardens Bexhill, Station Road Hurst Green, Station Road Robertsbridge, Tiverton Drive Bexhill

Introduction of No Waiting or Loading At Any Time - Rue De Bayeux Battle

Introduction of Disabled Persons Parking Places - Buckhurst Road Bexhill, North Road Bexhill, Reginald Road Bexhill

Introduction of Permit Holders Only 8am-6pm - Cooden Drive Bexhill

Introduction of Permit Holders Only 8am-6pm area - Richmond Close Bexhill

Introduction of Bus Stop Clearway No Stopping Mon to Sat 9:30am-3:30pm except Local Buses
- Ridgewood Gardens Bexhill

Introduction of Permit Holders or Paid-for Parking 8am-6pm - Cooden Drive Bexhill, Richmond Avenue Bexhill, Richmond Grove Bexhill, Richmond Road Bexhill

Introduction of Prohibition of Stopping on Footway or Verge at Any Time - Marina Bexhill

Removal of Disabled Persons Parking Places - Albany Road Bexhill, Manor Road Bexhill, Normandale Bexhill

Removal of Permit Holders Only 8am-6pm - Egerton Road Bexhill

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act of 1984, or on the grounds that any requirement of the Road Traffic Regulation Act or of any instrument made under it has not been complied with in relation to the Order, may within six weeks of the date the Order is made, apply to the High Court for this purpose.
