Statement of Reasons

The County Council has a duty under section 122 of the Road Traffic Regulation Act 1984 when making TROs to consider the expeditious, convenient and safe movement of traffic and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway. The East Sussex County Council as traffic authority propose to make the above-named order:

- a) For safety reasons in order to prohibit waiting at all times at certain junctions to preserve sight lines facilitate turning movements.
- b) To improve the air quality by improving traffic flow and reducing congestion.
- c)To ensure and facilitate free flow of traffic and access/egress
- d)To improve levels of available parking and manage parking demands.
- e) For preserving or improving the amenities of the area through which the road runs:

as indicated in the documents and map deposited.

These proposals are being promoted under the provisions of the Road Traffic Regulation Act 1984 which allows the Council to take measures under Section 1 where it appears to the authority in making the order that it is expedient to make it—

- (a) for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, or
- (b) for preventing damage to the road or to any building on or near the road, or
- (c) for facilitating the passage on the road or any other road of any class of traffic (including pedestrians), or
- (d)for preventing the use of the road by vehicular traffic of a kind which, or its use by vehicular traffic in a manner which, is unsuitable having regard to the existing character of the road or adjoining property, or
- (e)(without prejudice to the generality of paragraph (d) above) for preserving the character of the road in a case where it is specially suitable for use by persons on horseback or on foot, or
- (f) for preserving or improving the amenities of the area through which the road runs or
- (g) for any of the purposes specified in paragraphs (a) to (c) of subsection (1) of section 87 of the Environment Act 1995 (air quality).
